

General Terms & Conditions

In these general conditions, "Commissioner" refers to Legaldex, based in Zaandam and registered in the Commercial Register of the Chamber of Commerce of Amsterdam under number: 80749151.



1. Applicability

These General Terms and Conditions apply to all services and activities performed by Legaldex as the Commissioner. Legaldex is based in Zaandam and is registered in the Commercial Register of the Chamber of Commerce of Amsterdam under number: 80749151. These terms and conditions apply to all assignments, including supplementary and follow-up assignments, and to all relationships between Legaldex (Commissioner) and its clients.

2. Agreement for Assignment

All assignments are exclusively accepted and carried out by Legaldex (Commissioner) based on an agreement for assignment. Articles 7:404 and 7:407 paragraph 2 of the Dutch Civil Code are expressly excluded.

3. Engagement of Third Parties

Legaldex reserves the right to have assignments, under its responsibility, carried out by third parties. When engaging external parties, Legaldex will apply careful selection criteria. Legaldex is not liable for any shortcomings of third parties. If third parties limit their liability, Legaldex is authorized to accept such limitations on behalf of the Client.

4. Liability

The liability of Legaldex is limited to the amount covered by the professional liability insurance, increased by the deductible that is for the account of Legaldex in accordance with the policy conditions. If no payout occurs under this insurance, the liability of Legaldex is limited to the invoiced amount up to a maximum of EUR 25,000.

****5. Indemnification of Claims****

The Client indemnifies Legaldex against claims from third parties related to activities performed for the Client, including reasonable legal costs. This indemnification does not apply in case of gross negligence or intentional misconduct by Legaldex.

****6. Payment and Invoicing****

Legaldex invoices periodically for services rendered with a payment term of 14 days from the invoice date. A percentage of the fee is added to cover general office expenses. Costs advanced by Legaldex will be charged separately. All amounts are exclusive of VAT.

****7. Advance Payment****

Legaldex reserves the right to request an advance payment from the Client prior to the execution of the assignment. A received advance payment will be settled with the final invoice in the context of the assignment.

****8. Payment Default****

If payment is not received within the applicable term, the Client

will be in default without further notice. As of the due date, Legaldex is entitled to a default interest of 1% per month or part thereof.

****9. Applicable Law and Disputes****

The legal relationship between Legaldex and the Client is subject to Dutch law. Disputes will exclusively be settled by the competent court in Amsterdam.

****10. Language Difference****

These general terms and conditions are prepared in both Dutch and English. In case of differences in interpretation, the Dutch text shall prevail.
